

# NOTICE ON MARINAS

## for small ships and boats including yachts

The 14th National Counter-terrorism Committee chaired by the Prime Minister on February 11, 2022, **decided to designate and operate 10 marinas by region in order to enhance convenience by concentrating on CIQ duties as well as prevent the illegal entry of goods and persons that could pose security threat by strengthening the security of marinas.**

Accordingly, **small ships and boats including yachts must use the below 10 marinas for entry or departure to and from the Republic of Korea.** Kindly note the following information to avoid inconvenience.

\* i) The 10 designated marinas must be used as point of entry and departure. However, this does not mean that you cannot use other marinas after arrival. ii) When moving to another marina after initial entrance through a designated marina, you must comply with the entry and departure report procedures as stated in the relevant laws and regulations such as the Immigration Act, Customs Act, Ship Act, and Act on the Arrival and Departure of Ships.
